

Terms and Conditions

Welcome to Xdeel, a cryptocurrency exchange platform operated by Cidrus SP Z O.O. ("we," "our," or "us"). These Terms and Conditions ("Terms") govern your use of our website, platform, and services ("Service" or "Platform"). By accessing or using Xdeel, you agree to comply with and be bound by these Terms. If you do not agree with these Terms, you should not use our Platform.

1. Acceptance of Terms

By using the Xdeel Platform, you acknowledge that you have read, understood, and agree to be bound by these Terms, as well as our Privacy and Cookie Policy, which is incorporated by reference into these Terms. The Privacy and Cookie Policy outlines how we collect, use, and protect your personal data and how we use cookies and similar technologies.

2. Eligibility

b. Prohibited Activities

You are expressly prohibited from:

- Copying, modifying, creating derivative works of, or publicly displaying any content or software from the Platform without our prior written consent.
- Using any automated means (such as bots, crawlers, or scrapers) to access the Platform for any purpose.

5. Transactions on the Platform

a. General

All transactions on the Xdeel Platform are subject to these Terms. You acknowledge that cryptocurrency transactions are irreversible and that the value of cryptocurrencies can fluctuate significantly. You understand and accept the risks associated with trading cryptocurrencies.

b. Fees

We may charge fees for certain transactions on the Platform. Any applicable fees will be disclosed to you before you complete a transaction. You agree to pay all applicable fees associated with your use of the Platform.

c. No Investment Advice

The content provided on the Platform is for informational purposes only and does not constitute investment advice. We do not endorse or recommend any particular cryptocurrency or trading strategy. You should conduct your own research and consult with a financial advisor before making any investment decisions.

6. Intellectual Property

a. Ownership

The Platform and its entire contents, features, and functionality (including all information, software, text, displays, images, video, and audio) are owned by Cidrus SP Z O.O., its licensors, or other providers of such material and are protected by international copyright, trademark, patent, trade secret, and other intellectual property or proprietary rights laws.

b. Limited License

We grant you a limited, non-exclusive, non-transferable, and revocable license to access and use the Platform for personal, non-commercial purposes, subject to these Terms. You must not reproduce, distribute, modify, create derivative works of, publicly display, publicly perform, republish, download, store, or transmit any material on our Platform, except as explicitly permitted by these Terms.

7. Termination

We may terminate or suspend your account and access to the Platform at our sole discretion, without prior notice, for conduct that we believe violates these Terms, is harmful to our interests, or for any other reason. Upon termination, your right to use the Platform will immediately cease, and you must destroy any downloaded or printed materials obtained from the Platform.

8. Limitation of Liability

To the fullest extent permitted by law, in no event shall Cidrus SP Z O.O., its affiliates, or their respective directors, officers, employees, agents, licensors, or service providers be liable for any indirect, incidental, special, consequential, or punitive damages, including but not limited to loss of profits, data, use, goodwill, or other intangible losses, arising out of or in connection with your use of or inability to use the Platform.
